# PART 1 – POSITION SUMMARY

The OSSTF/FEESO legal department specializes in education labour law on behalf of 60,000 English and French education workers who are employees of school boards, universities and other educational institutions in Ontario. Articling work would involve litigation and legal support in the areas of: Grievance Arbitration, Professional Regulatory complaints, Labour Board matters, Human Rights, Employment Standards, Workers' Safety and Insurance, Long Term Disability, Occupational Health and Safety, Civil Litigation, Pensions and Collective Bargaining. OSSTF encourages applications from students with a demonstrated interest in union side labour law.

## DUTIES AND RESPONSIBILITIES (not listed in order of priority)

- Draft legal submissions, administrative tribunal applications and responses, as well as pleadings and facts.
- Interview witnesses and grievors.
- Regularly accompany our lawyers to hearings before administrative tribunals and courts.
- Conduct legal research.
- Appear at grievance arbitrations and before various administrative tribunals.
